### Agenda items

1. Pulham Falcon has closed, the Pulham team will now play at Scole Crossways, the fixtures have been updated.
2. Scole Inn is removing its pool table, the team playing at Scole Inn will relocate to Dickleborough Crown, the fixtures have been updated.
3. The semi final draws for the Team Knockout Cup and Subsidiary Cup were completed.
4. The Ladies Singles Knockout will take place on Thursday 11<sup>th</sup> May at Attleborough Snooker Centre, 7pm for 7-30pm start.

9. Hockham Eagle I's requested to claim the cancelled game against Bar 33, which Bar 33 cancelled due to having a cellar refurbishment. The committee decided that the game must be replayed and points would not be awarded to Hockham Eagle I's
10. League winners and runners up will be invited to Finals Night to have their trophies presented between matches. If teams don't wish to attend the Finals Night, the trophies will be delivered to their venue after the event.
11. We have been quoted approximately £2,000 for the trophies that need to be purchased this year. The committee will seek sponsorship for the new main trophies.
  - The trophies that Tunmores agreed could be passed to the new committee have now been collected.
  - It was agreed to continue with the 8 Ball Break trophies
12. The balance of the bank account stands at £2,943.98 and we have to pay for new trophies and finals night referees etc.
13. Tim has had no response from Ian at Tunmore Leisure to his email dated 8<sup>th</sup> January regarding the financial queries, these include:
  - Two cheques for £533.00 and £780.00 that were raised after the accounts were presented at the AGM, Tim has asked what these payments were for.
  - Tunmore collected £1,400.00 in Winter League entry fees but only £1,050.00 was transferred to the new bank account
